

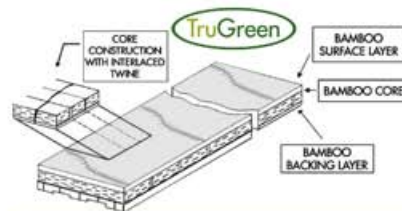

This "thread" allows for slight expansion and contraction in the core as well as increased precision in the manufacturing process. Overall, the **TruGreen** core construction provides the most stable platform on the market while still maintaining its status as 100% Rapidly Renewable Resource.

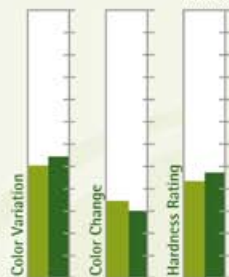
